TERMA RUJUKAN

- ◆ Mengatasi masalah kelewatan pelaksanaan projek dan program perindustrian & perkhidmatan di peringkat daerah.

FUNGSI

- ◆ Mempastikan pelaksanaan projek-projek perkilangan dan perkhidmatan yang telah diluluskan berjalan dengan lancar mengikut jadual yang ditetapkan oleh pelabur;
- ◆ Menyelaraskan pelaksanaan projek-projek perkilangan dan perkhidmatan berkaitan perkilangan di kalangan pelbagai Jabatan/Agensi di peringkat daerah;
- ◆ Mempercepatkan pelaksanaan projek-projek perkilangan dan perkhidmatan yang telah diluluskan;
- ◆ Menyediakan mekanisme pemantauan yang berkesan ke atas projek-projek perindustrian dan melaporkan kemajuannya;

DISTRICT INDUSTRY IMPLEMENTATION UNIT (DIU)

DECISION OF SABAH STATE GOVERNMENT CABINET

Has agreed to the implementation of District Industry Implementation Unit (DIU) in all district / local authorities in Sabah (SKN, 31 January 2007).

TERMS OF REFERENCE

- ◆ To resolve the problem of project implementation delay and industrial program and services at the district level.

FUNCTION

- ◆ To ensure that the implementation of approved manufacturing projects and services according to schedule as set out by the investors;
- ◆ To coordinate the implementation of manufacturing projects and manufacturing related services among various departments / agencies at the district level;
- ◆ To expedite the implementation of approved manufacturing projects and services;
- ◆ Providing an effective monitoring mechanism on industrial projects and report on the progress of implementation;
- ◆ Assist private companies in dealing with various departments / agencies at the district level to obtain approval for trading license, factory site, etc; and
- ◆ Maintain close working relationships with all departments / agencies.

BACKGROUND

- ★ The set up of DIU was announced by Minister of MITI on 15 August 2006;
- ★ Objective: To Improve the efficiency of the implementation system of manufacturing projects and services at the district level;
- ★ Scope of work: Only focused on the implementation delay of the manufacturing projects at the district level.
